- e. Security cameras were given. However the footage only held two weeks.
- f. Davis stated he was told there was a car pulled over and three guys were in it and one of the three was lying in the back seat. All stated they were at Fazes. His claim is that now the gender has been changed to a female.

## Mayor's Response:

- a. Mayor asked him if he was present at the Council meeting in November. Davis stated he was. Then she read him the Conditions and asked if he was aware of them. He stated he had only heard them verbally. See report.
- b. He had been cited for buying alcohol from a local vender.
- c. The conditions were violated.
- d. She asked everyone to let it be known by shows of hands all that are opposed of giving back the Alcohol license. Four voted to deny renewal of alcohol license. Councilman Barnes was not in favor of denial.

## Mr. Davis Response:

a. Davis said the State Department of Revenue issue is just a citation. He had been alleged of purchasing alcohol from a non-distributor.

# Mayor:

a. Asked, if that was legal?

## Councilman Lane:

a. Asked about the alleged purchase?

## Mr. Davis:

a. It is against regulations and his case is being heard on July 12 in Macon. He said he is alleged of purchasing from a non-distributor.

## Councilman Lane:

a. Asked, "Have you received and certified letters from the City"?

#### Mr. Davis:

- a. I have not received a single one. He stated the City Marshall knew because one of the letters had been returned to him. He stated, the City Marshall called him and told him he had to attend the Council Meeting, but wouldn't tell him why he had to attend.
- Davis said he had his mail forwarded to his new address because he had moved from Warner Robins.

#### Councilman Allen:

a. Asked him about his cameras?

#### Mr. Davis:

a. Davis said he has cameras surrounding his business. He stated that he also wears a body camera on him every night. He has 3 cameras outside. He stated he has done everything he was told to do to meet the condition requirements.

## Councilman Brown:

a. Asked Chief Spurgeon about incident.

## Chief Spurgeon:

a. Reported two main incidents- One with the juvenile and the other with the State Revenue Board for purchasing alcohol from a non-distributor. Both of the incidents were within his 6 month probationary period.

Motion by Councilman Lane to deny renewal of alcohol license.

Councilman Allen 2<sup>nd</sup> the motion. 4 voted to deny renewal of alcohol license. Councilman Barnes voted not in favor of denial.

#### Committee Reports:

**Economic Development Committee:** Councilman Allen reported that the walking trail at the Festival Park is being finished. The Austin Theatre is hosting a Sip, See N Stroll July 7<sup>th</sup>. The cost will be \$48.

**Public Works Committee:** Councilman Barnes reported that the cemetery is looking great and the walking Trail at the Festival Park is being finished. Ben has is hiring a temporary Class A driver.
